

ALSO: All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate, lying and being in the City of Greenville on the eastern side of Sitka Avenue and being known and designated as Lot 32 of Parkview as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book M, Page 49 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Sitka Avenue (formerly known as King Avenue) which iron pin is 61 feet in a northerly direction from the northeast corner of the intersection of Sitka Avenue and Alaska Avenue (formerly Morningside Drive), and which iron pin is at the joint front corner of Lots 32 and 33 and running thence along the eastern side of Sitka Avenue N. 26-15 W., 50 feet to an iron pin joint corner Lots 32 and 31; thence along the line of Lot No. 31 N. 63-45 E., 150 feet to an iron pin joint rear corner Lots 31 and 32; thence S. 26-15 E., 50 feet to an iron pin joint rear corner of Lots 32 and 33; thence along the line of Lot 33 S. 63-45 W., 150 feet to the beginning corner.

ALSO: All that piece, parcel or lot of land situate, lying and being in Chick Springs Township near the City of Greenville and having according to survey of Dalton and Neves, June, 1946, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Hall Road joint corner of property now or formerly owned by Mrs. M. A. Bryant and Lee Hall and running thence N. 52 E., 206.42 feet to an iron pin; thence N. 60-55 W., 101 feet to an iron pin; thence S. 49 W., 190 feet to an iron pin on the north side of Hall Road; thence with said Road, S. 60-15 E., 30 feet to a stake; thence continuing with said Road, S. 48 E., 59 feet to the point of beginning. The mortgagor, James R. Mann, owns a one-half undivided interest in and to this parcel.
