All that certain piece, parcel, or lot of land, with all improvement thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Chateau Drive, near the City of Greenville, being shown as Lot 132 on plat of Merrifield Park, Section 1, recorded in Plat Book OOO at Page 177 in the R.M.C. Office for Greenville County and having the following metes and bounds, to-wit;
