WHEREAS, the Mortgagor is well and truly indebted unto

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Two Thousand Five Hundred Twenty and No/100 (\$2,520.00) Dollars** -----

with interest thereon from date at the rate of **7** per centum per annum, said principal ~~amount~~ to be repaid: in monthly installments of **Seventy (\$70.00) Dollars** each with the first payment being due and payable July 30, 1969 and continuing monthly thereafter until paid in full; interest to be paid in advance.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township and being more particularly described as follows:

Beginning at a nail and cap on Kelly's Mill Road at a road that leads North to Highway No. 415, and running thence with Kelly's Mill Road, S 79-55 E 210 feet to a point; thence S 0-30 W 210 feet to a point; thence N 79-55 W 210 feet to a point in Ruth P. Kelly's line; thence N 0-30 E 210 feet to the point of beginning.

This is the identical property conveyed to the mortgagors herein by deed recorded in Deed Book 869, Page 167.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had thereon and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intent of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
