TOGETHER with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or apportaining, including all heating, plumbing and electrical fixtures, and any other equipment or fixtures now of hereafter attached, connected or fitted in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than household furniture, be considered a part of the realty.

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever,

The Mortgagor represents and warrants that said Mortgagor is seized of the above described premises in fee simple absolute; that the above described premises are free and clear of all liers or other encumbrances; that the Mortgagor is lawfully get, its successors and assigns, from and against the Mortgagor will forever defend the said premises unto the Mortgagor, its successors and assigns, from and against the Mortgagor and every person whomsoever lawfully claiming or to claim the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- 1. That the Mortgager will promptly pay the principal and interest on the indebtedness evidenced by said promissory note at the times and in the manner therein provided.
- 2. That this mortgage will secure the Mortgagee for any additional sums which may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, or public assessments, hozard insurance premiums, repairs or other such purposes pursuant to the provisions of this mortgage, and also for any loans or advances that may hereafter be made by the Mortgagee to the Mortgage to under the authority of Sec. 45-55, 1992 Code of laws of South Carolina, as amended, or similar statutes; and all sums so advanced shall bear interest at the same rate as that provided in said note and shall be payable at the demand of the Mortgagee, unless otherwise provided in writing.
- 3. That if this mortgage secures a "construction loan", the Mortgagor agrees that the principal amount of the indebtedness hereby secured shall be disbursed to the Mortgagor in periodic payments, as construction progresses, in accordance with the terms and conditions of a Construction Loan Agreement which is separately executed but is made a part of this mortgage and incorporated herein by reference.
- 8. That the Mortgagor will not further encumber the premises above described, nor alienate said premises by way of national each of conveyance without the prior consent of the Mortgage, and should the Mortgager so encumber or alienate such premises, the Mortgager may at its option, declare the indebtedness hereby secured to be immediately due and payable and may institute any proceedings necessary to collect said indebtedness.

That the Murtgager breeby assigns to the Mortgagee, its successors and assigns, all the reuts, issues, and profits accruing from the mortgaged premises, retaining the right to collect the same so long as the debt bereby secured is not in arrears of payment, but should any part of the principal indebtedness, or interest, taxes, or fire insurance premium, he past due and unpoid, the Mortgagee may without notice or further proceedings take over the mortgaged premises. If they shall be occupied by a tenant or transts, and collect said rents and profits and apply the same to the indebtedness hereby secured, without liability to account for anything more than the rents and profits actually collected, less the cost of collection, and any tenant is authorized, upon request by Mortgagee, to make all rental payments direct to the Mortgagee, without hability to the Mortgager, and should said promises at the time of such default be excupied by the Mortgager, the Mortgage may apply to the Judge of the County Court or to any Judge of the County of Common Pleas who shall be resident on precising in the county aforesaid for the appointment of a receiver with authority to take possession of said premises and collect such rents and profits, applying said rents, after paying the cost of collection, to the mortgage debt without liability to account for anything more than the rents and profits actually collected.
