All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the major portion of Lot No. 5, Block P, of Highland Subdivision, property of H. K. Townes, according to a plat thereof prepared by Dalton & Neves, July, 1940 and recorded in the R. M. C.
