NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, end of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagoe in thand well and truly paid by this Mortgagoe at and before the sealing and delivery of these presents, the recipit whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, self and release unto the Mortgagoe, its successors and assisms:

"ALL that certain place, parcel or let of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Caroline, County of Circonville, Austin Township, about 3.5 miles East of the Town of Simpsonville, on the Northwest side of State Highway No. 417, known and designated as Lot 学, containing 9.36 acres, more or loss, as shown on a plat of property of N.B. Cooper prepared by C.O. Aiddle, Surveyor, in August 1957, and having, according to said plat, the following courses and distances, to-wit:

Deginning at an iron pin on the Northwestern edge of South Carolina Pighway #17, joint front corner with Lot No. 5 as shown on said plat, said pin measuring a distance of 29.9 feet from conter of said Highway, and running thence with the joint line of said Lot #5 N. 55-35 M. 1352 feet to an iron pin, back joint corner with Lot #5; thence S. 33-36 W. 299 feet to an iron pin, back joint corner with Lot #3; thence with the joint line of Lot #3 S. 55-35 E. 1323.2 feet to an iron pin in the Northwestern edge of said Highway, joint front corner with Lot #3, said pin measuring a distance of 25.7 feet fra a point in the center of said road; thence ". 39-06 E. along the Northwestern edge of said road 300 feet to an iron pin, the point of beginning and being bounded by lots #3 and #5, and said Highway.
