MORTGAGE OF REAL ESTATE

Fifty Nine and 65/100 (\$59.65) Dollars due and payable on the first day of January, 1970 and each month thereafter for twenty years.

Last payment due with interest thereon from date at the rate of $6\ 1/2$ par centum per annum, to be paid: Twenty years from date.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgages for such further sums as may be advanced to or for the Mortgagor's account for laxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum or Three Dollars (\$3.00) to the regions in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville with the buildings and improvements

thereon, situate and shown as the Easterly portion of Lot No. 64 on plat of property of Walter L. King, Jr., which plat is recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book CCC at Page 89, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Louise Avenue, which iron pin is the joint front corner of Lots Nos. 64 and 65, and running thence along the joint line of said Lots N. 37-35 W. 133.6 feet to an iron pin; thence S. 60-30 W. 45 feet to an iron pin; thence S. 27-34 E. 116.2 feet to an iron pin on the Northwesterly side of Louise Avenue; thence along Louise Avenue N. 73-50 E. 70 feet to an iron pin, the point of beginning.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, of filted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lowfully selzed of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to tell, convey or encumbes the same, and that the premises are free and clear of all lines and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
