NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is breely acknowledged, has granted, borgained, solf, and teclased, and by these presents does grant, largain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 115 of a subdivision known as Coleman Heights according to a plat thereof prepared by Terry T. Dill dated February, 1958, recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of West Drive at the joint corner of Lots Nos. 115 and 126, and running thence with the eastern side of West Drive, N. 18-52 W. 124.8 feet to an iron pin at the intersection of West Drive and Coleman Drive; thence with the curvature of said intersection, having a radius of 25 feet, to an iron pin on the southern side of Coleman Drive; thence with the southern side of Coleman Drive, N. 71-33 E. 149.8 feet to an iron pin; thence continuing N. 81-12 E. 86 feet to an iron pin at the joint corner of Lots Nos. 115 and 116; thence with the joint line of said lots, S. 80-45 E. 136.5 feet to an iron pin; running thence with the joint line of Lots Nos. 115 and 126, S. 71-05 W. 235.2 feet to an iron pin on the eastern side of West Drive, the point of beginning; being the same conveyed to me by Stanley I. Coleman by deed of even date, to be recorded herewith.
