WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagor for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, barganed, sold and released, and by these presents does grant, bargain, sell and release out to the Mortgagor, its successors and assigns:

"ALL that certain piece, parcel or lot of hand, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Eastbourne Road in the County of Greenville, State of South Carolina, being shown and designated as Property of Ralph Kay on a plat thereof prepared by Jones Engineering Service, September 14, 1968, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the southeastern edge of Eastbourne Road, 580 feet, more or less, from White Haven Drive, and running thence along the southeastern edge of Eastbourne Road S. 57-00 W. 200 feet to a point; thence along the line of Moore Property S. 33-00 E. 250 feet to a point; thence N. 57-00 E. 200 feet to a point; thence N. 33-00 W. 250 feet to the point of beginning, and being Lot 1.9 according to County Auditor's Block Book.

PURCHASE MONEY MORTGAGE

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mottgagor covenants that it is lawfully seized of the premites hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises ore free and clear of all liens and excumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all-bersors whomsower lawfully claiming the same or any part thereof.
