To All Whom These Presents May Concern:

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgager is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

therein specified in installments of One Hundred Eighty-Two and 94/100----- (s. 182, 94). Dollars each on the first day of each month bereafter, in advance, until the principal sum with interest has been full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then the payment of principal with the last payment, if not sooner paid, to be due and payable. 12 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal, due, and interest, with costs and expenses for such proceedings:

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgager for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at any before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and telested, and by these presents does grant, bargain, sell and release unto the Mortgager, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all Improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Wildwood Road, near the City of Greenville, being shown as Lot No. 40 on plat of Woodland Hills recorded in Plat Book Y, at Page 60 and described as follows:

BEGINNING at a stake on the western side of Wildwood Road at the corner of Lot No. 41, and running thence with line of said lot, S. 73-00 W. 139 feet passing a pin to a point in the center line of creek; thence with the creek as the line, the traverse of which is N. 43-06 W. 111.3 feet to a point at corner of Lot No. 39; thence with the line of Lot No. 39 passing an iron pin, N. 73-00 E. 188 feet to a stake on Wildwood Road; thence with the western side of said road, S. 17-00 E. 100 feet to the beginning corner; being the same conveyed to us by J. B. Compton by his deed dated March 17, 1961 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 670, at Page 132.

The mortgagors promissory note referred to above contains, among other things, a provision for an increase in the interest rate.
