MODIFICATION AGREEMENT

INCREASING INTEREST RATE

STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE

- WHEREAS Fidelity Federal Savings and Loan Association of Greenville, South Carolina, is the owner and holder of a promissory note dated-16-69 executed by Cothran & Darby Builders, Inc. in the original sum of \$33,700.00 bearing interest at the rate of 71/2% and secured by a first mortgage on the __, which is recorded in the premises being known as Lot 9 Pilgrims Point Drive RMC Office for Greenville County in Mortgage Book 1126, page 24, title to which property is now being transferred to the Obligor, who has agreed to assume said mortgage loan and to pay the balance due thereon; and

WHEREAS Fidelity Federal Savings and Loan Association of Greenville, South Carolina, has agreed to said transfer of ownership of the mortgaged premises to the Obligor and his assumption of the mortgage loan, provided the interest rate on the balance due is increased from $7 \frac{1}{2}$ to $\frac{8}{3}$,

NOW, THEREFORE, this agreement made and entered into this 6th day , 1970, by and between Fidelity Federal Savings and Loan of Association of Greenville, South Carolina, as mortgagee, and Cothran & Darby __ as Obligor, Builders, Inc.

WITNESSETH:

In consideration of the premises and the further sum of \$1.00 paid by the Association to the Obligor, receipt of which is hereby acknowledged, the undersigned parties agree as follows:

(1) That the interest rate on the loan balance of 33,525.87 be increased to 8%.

(2) That the Obligor agrees to repay said obligation in monthly installments of \$258.70ach, with payments to be applied first to interest and then to the remaining principal balance due from month to month, with the first monthly payments being due February 20

(3) That all terms and condition as set out in the note and mortgage shall continue in full force, except as modified expressly by

this Agreement.

(4) That this Agreement shall bind jointly and severally the successors and assigns of the Association and Obligor, his heirs, successors and assigns.
