5. That Marigagor (i) will not remove or demolish or alter the design or structural character of any building now or hereafter exected upon the premises unless Marigagee shall first consent thereto in writing; (ii) will maintain the premises in good condition and repair; (iii) will not commit or suffer waste thereto; (iv) will not cut or remove or suffer the cutting or removal of any trees or timber on the premises (except for domestic purposes) without Marigagee's written consent; (v) will comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting the premises, and will not suffer or permit any volution thereto.

9. No delay by Mortgagee in exercising any right or remedy hereunder, or otherwise afforded by law, shall operate as a waiver thereof or preclude the exercise thereof during the continuance of any default hereunder.
