"ALL that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, silvate, [v]ng and being in the State of South Carolina, County of Greenville, being in the City of Greenville, being known and designated as Lot No. 6, Mock A, as shown on a plat of a subdivision known as Carolina Court of record in the Office of the RMC for Greenville County in Plat Book F, Page 96, with the lot fronting 65 feet on the Northwestern side of Eastlan Drive, reference to said plat being craved for a metes and bounds description thereof.

This mortgage is junior and subordinate to that certain mortgage given to Aiken Loan & Security of record in the Office of the RMC for Greenville County in R. E. M. Book 904, Page 213 this date assumed by the mortgagors.
