RICHLAND COUNTYSITE NO. 1.

All of that piece, parcel or lot of land, situate, lying and being in the incorporated municipality of Forest Acres, on Forest Drive, a paved Highway known as State Highway No. 12, in the County of Richland, State of South Carolina, the said lot being fully designated and shown on a plat prepared for C. O. Taylor and W. F. Rogers by William Wingfield, Surveyor, as of October 3, 1952, and found of record in the Clerk of Court's Office, County of Richland, in Plat Book 3 at page 68, as of October 9, 1952, the said tract of land being enclosed by a fence and bounded as follows: On the North by lands now or formerly of Bram Taylor and running thereon S 65-30 W for a distance of One Hundred Seventy Five (175') feet to an iron corner at the intersection of Troy Road; on the East by Troy Road and running thereon N1-00 E for a distance of One Hundred Sixty-Five (165') feet to a point of intersection designated by an iron pin on Forest Drive; on the South by Forest Drive, a paved state highway known as No. 12 and running thereon N 66 E for a distance of One Hundred Twenty Six (126') feet to a point of intersection with lands of William B. Grainger; and on the West by lands of William B. Grainger and running thereon S 15-30 E for a distance of One Hundred Fifty (150') feet to the point of commencement, which is designated by an iron pin. This being the land conveyed unto C. O. Taylor and W. F. Rogers by deed of William B. Grainger, recorded in Deed Book 100 at page 511, as of October 16, 1952, in the office of the Clerk of Court for Richland County.

SITE NO. 2.

All those two certain pieces, parcels or lots of land situate, lying and being on the eastern side of the Broad River Road in development known as Elm-Abode north of the city of Columbia, in the County of Richland, and State of South Carolina, being shown and designated as Lot No. 1 and Lot No. 2 in Block "A", as shown on a certain map of Elm-Abode made by James C. Covington, E.E., dated April 12, 1952, and also shown as Lot No. 1 and 2 on a certain plat of property surveyed for Frank F. Rogers, made by James C. Covington, C.E., dated November 5, 1952, said plat being recorded in the office of clerk of Court for Richland County, South Carolina, said two lots combined being bounded as follows: On the North by property of persons not known and measuring thereon for a distance of One Hundred Forty (140') feet; on the East by Lot No. 12 and a portion of Lot No. 11 in Block "A", as shown on said plat, and measuring thereon for a distance of Two Hundred (200') feet; on the South by Lot No. 3 in Block "A" as shown on said plat, and measuring thereon for a distance of One Hundred Twenty Nine and Seven Tenths (129.7') feet; and on the West by Broad River Road and measuring thereon for a
