of Richland, in the State of South Carolina, on the southwestern side of Broad River Road (U.S. Hwy. 176) and having the following courses and distances: Commencing at an iron at the southwestern corner of the intersection of Broad River Road (U.S. Hwy. 176) and Inland Drive and running thence S $38^{\circ}-30'$ E. Forty-one and four tenths (41.4') feet to an iron, thence S $2^{\circ}-00'$ W Fifty-three and two tenths (53.2') feet to the point of beginning of the parcel of land herein described; thence S $2^{\circ}-00'$ W One Hundred Thirty-three (133') feet to an iron; thence north $38^{\circ}-36'$ W Fifty-one (51') feet to an iron; thence N $14^{\circ}-18'$ E Eighty-four and three tenths (84.3') feet; thence N $51^{\circ}-12'$ E. Nineteen (19') feet to the point of beginning. Said parcel being bounded on the north by land formerly of Irvy J. Hawkins, now Southland Oil Corporation, on the east by land of Southland Oil Corporation, on the south and west by land of Mary E. Hawkins.

All that certain tract or lot of land, with the improvements thereon, situate, lying and being on the southwestern side of U. S. Highway No. 76, approximately five (5) miles northwest of the City of Columbia, in the County of Richland, State of South Carolina; being more fully shown and designated as Lot No. 1 on a plat of the property of the heirs of J. W. Shealy as prepared by Carl B. Shuler, C.E., dated May 15, 1950; said tract being triangular in shape and commencing at a stake, located at the northwestern point of said tract where same intersects with U. S. Highway No. 76 (South Carolina Highway No. 2) thence running southeast along said Highway for a distance of 186.3 feet to a stake; thence turning at right angles and running southwest for a distance of 156.8 feet to a stake; thence turning at a right angle and running north a distance of 243.5 feet to the point of beginning. Said property being bounded on the northeast by U. S. Highway No. 76 (South Carolina Highway No. 2), on the southeastern side by Lot No. 2 of said plat, on the western side by property now or formerly of A. M.
