

RESOLUTION PASSED BY THE
 TRINITY LUTHERAN CHURCH, GREENVILLE, S.C.
 GREENVILLE, SOUTH CAROLINA

"WHEREAS, the TRINITY LUTHERAN CHURCH, GREENVILLE, S.C., Greenville, South Carolina, a corporation not for profit, formed for religious purposes organized pursuant to the laws of the State of South Carolina, hereinafter called the Church, desires to borrow money for the erection or construction of a place to worship as it desires and to equip the improvements in order that they may be used for the purposes herein contained; and

WHEREAS, it is the desire of the Church to authorize the issuance of a series of First Revenue Bonds:

NOW, THEREFORE, BE IT RESOLVED by the TRINITY LUTHERAN CHURCH, GREENVILLE, S.C., Greenville, South Carolina:

ARTICLE I: That the Church does by these presents hereby authorize the issuance of a series of First Revenue Bonds to be known as "Series of May 10, 1970", in the aggregate amount of ONE HUNDRED THOUSAND DOLLARS (\$100,000.), at varied rates of interest to include 6%, 6-1/2%, 6-3/4%, 7% and 7-1/2% per annum; and the serial numbers, denominations, interest rates and maturity dates of the First Revenue Bonds to be issued as "Series of May 10, 1970", are as follows:
