in the full and just sum of TWO THOUSAND DOLLARS PLUS INTEREST \*\*\*\*)\*\* (\$2000.00)

\*\*\*\*\* to be paid BEGINNING THE 2nd FRIDAY OF AUGUST, AND EACH 2nd FRIDAY OF THE MONTH UNTIL PAID IN FULL, PAYMENTS OF FIFTY DOLLARS PER MONTH INCLUDING INTEREST

with interest thereon from July 8th, 1970

at the rate of 6 per cent, per annum, to be computed and paid monthly (INCLUDED IN THE \$50.00 payment)

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

C. E. LONG, HIS HEIRS AND ASSIGNS FOREVER.

ALL THAT CERTAIN PIECE, PARCEL OR LOT OF LAND IN GROVE TOWNSHIP, IN GREENVILLE COUNTY, AND STATE OF SOUTH CAROLINA, CONTAINING 3 1/4 ACRES, MORE OR LESS, SITUATED AND LYING ADJACENT TO THE GREENVILLE AND ANDERSON HIGHWAY AND HAVING THE FOLLOWING METES AND BOUNDS.

BEGINNING AT AN IRON PIN ADJOURNING THE LOT OF C. E. LONG, THENCE RUNNING S-89-30 W. FOR A DISTANCE OF 210 FEET, TO A STONE, THENCE N -18-00 E. FOR A DISTANCE OF 669 feet (OR 10 chains and 15 links) to iron pin, thence S- 45 E for a distance of 210 feet, then N.-18-00 W for a distance of 625 feet and back to the beginning point.

This lands is surrounded by lands belonging to C. E. Long, S. M. Jones and on either side by a county owned hard surface road which have not been named.
