Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said PALMETTO SAVINGS AND LOAN ASSOCIATION OF LAURENS, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee-simple absolute, and that he has good right and lawful authority to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumberances whatsoever. The rath is reserved unto the said Association to have a herein provided for.

It is also acreed that if at one time the said Association should accept any preparament of the principal indebtedness due bereunder, that such acceptance of prepayment shall not constitute a waiver by said Association of any of its rights under this mortgage or the note occurred thereby, nor obligate the said Association to accept further prepayments of the principal indebtedness.
