NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 102, Pine Forest, on plat prepared by Dalton and Neves, August 1959, recorded in the R.M.C. Office for Greenville County in Plat Book "QQ", Pages 106 and 107, and having according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the Northern side of Mapleton Drive at the joint front corner of Lots Nos. 102 and 103 and running thence with line of lot 103, N. 26-30 W. 138 feet to an iron pin corner of Lots Nos. 55, 56, 102 and 103; thence running with rear line of Lot No. 56 S. 63-30 W. 100 feet to an iron pin at joint rear corner of Lots Nos. 56, 57, 101 and 102; thence running with line of Lot No. 101, S. 26-30 E. 138 feet to an iron pin on the Northern side of Mapleton Drive; thence running with Mapleton Drive, N. 63-30E. 100 feet to the beginning corner.
