All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Mauldin, being known and designated as lot No. 46, Section 2, on plat of Sunset Heights, recorded in plat book RR page 85 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:
