

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Greer, on the southeastern side of Harris Drive at its intersection with Pinecrest Drive and known and designated as Lot No. 48 on a plat of property of H. H. Cox which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 4H at Page 37 and according to said plat has the following metes and bounds, to-wit:
