BEGINNING at an iron pin on the north side of Clark Avenue, corner of Lots Nos. 46 and 47, and running thence along the line of said lots, N. 11-02 E. 170 feet to the rear corner of Lot No. 45; thence along the line of Lot No. 45, S. 79-25 E. 137.3 feet to an iron pin on the west side of Clark Avenue; thence along said Avenue, S. 35-30 W. 160.6 feet to a curve in said Avenue; thence along said Avenue in a curving line, the chord of which is S. 68-03 W. 45.2 feet to an iron pin; thence continuing along said Avenue, N. 79-25 W. 31.6 feet to the beginning corner.
