NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that lot of land with the buildings and improvements thereon, situate on the South Side of Loe Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Tots\_Hos. 7,8, 9 and 10 on plat of property of James Edwards, prepared by Dalton and Neves, Engineers, February. 1941, and having according to said plat, the following metes and bounds, to Wit:

BEGINNING at an iron pin on the south side of Lee Road at corner of Lots Nos. 10 and 11, and running thence along the south side of Lee Road, N. 73-44 E. 454.8 feet to an iron pin; thence along the line of Lot No. 7, S. 13-07 E. 314 feet to an iron pin; thence 3. 73-29 W. 450.4 feet to an iron pin; thence along the rear line of Lots Nos. 11,12 and 13, N. 14-08 W. 301 feet to an iron pin on the south side of Lee Road, the beginning corner.
