To All Whom These Presents May Concern:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall; at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of El Paso Drive, being shown as Lot No. 24 on plat of WESTERN HILLS

THE MORTGAGOR'S PROMISSORY NOTE REFERRED TO ABOVE, CONTAINS, AMONG OTHER THINGS, A

Section 1 and 2 made by Jones and Sutherland, Engineers dated August 1959, recorded in the RMC Office for Greenville County, S. C. in PROVISION FOR AN INCREASE IN THE INTEREST RATE. Plat Book QQ, pages 98 and 99, and having,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwestern side of El Paso Drive at the joint front corner of Lots No.s 23 and 24 and running thence S. 14-28 W., 199.2 feet to an iron pin; thence S. 65-21 W., crossing a branch 77.5 feet to an iron pin; thence N. 39-43 W., 202.8 feet to an iron pin; thence along the line of Lot No. 25, N. 50-17 E., 250 feet to an iron pin on El Paso Drive; thence with the curve of El Paso Drive the following chord: S. 21-23 E., 47.4 feet to an iron pin and S. 41-06 E., 61.5 feet to an iron pin, the beginning corner.

This mortgage is given in connection with a construction loan, \$\delta\$nd it secures a promissory note which provides, among other things, for monthly interest payments, the principal payable in full on or before 12 months from date, and a provision for an increase in the interest rate.
