NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 4 on plat entitled "Property of T. D. Burdette", prepared by C. O. Riddle, dated 8/20/70, and having according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin in center of Butler Drive and running thence along the line of Lot No. 3, S. 6-27 W., 426.4 feet to an iron pin; thence N. 84-18 E., 627 feet to an old iron pin; thence N. 6-27 E., 213.2 feet to an old iron pin; thence S. 84-18 W., 418 feet to an iron pin; thence with the line of Lot No. 5 N. 6-27 E., 213.2 feet to an iron pin in center of Butler Drive; thence with the center line of Butler Drive, S. 84-18 W., 209 feet to the beginning corner, containing 4 acres, more or less.
