All that certain piece, parcel, or lot of land situate, lying and being on the South side of Long Hill Street, in the City of Greenville, being known as lot 88 on plat of Augusta Road Hills, made by Dalton & Neves, December 1940 recorded in the RIC Office of Greenville County, S.C. in plat Book M page 33 and also being shown on a more recent plat of property of M. L. Thomas and R.K.
