**MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

RANDALL D. AND BARBARA W. GRICE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWENTY-TWO THOUSAND FOUR HUNDRED AND NO/100THS--

DOLLARS (\$ 22,400.00), with interest thereon from date at the rate of EIGHT (8%) per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at Travelers Rest, S. C., known as Lot 1, containing six (6) acres, more or less, on plat of Property of George W. Bridwell, recorded in the R. M. C. Office for Greenville County in Plat Book M, page 129, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of McElhaney Road at the corner of J. O. Cooper Property, and running thence N 16-09 W 820 feet to an iron pin; thence S 68-40 W 337.4 feet to an iron pin; thence S 20-01 E 865 feet to an iron pin on the northern side of said Road; thence with said Road, N 59-50 E 286.1 feet to the point of beginning and being the same property conveyed to the Mortgagors by H. G. Miller by deed to be recorded of even date herewith.

This property is subject to easements and restrictions of record in the Greenville County Courthouse, including a right-of-way for sewer purposes for the Town of Travelers Rest in Deed Book 856, page 371.
