"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township on the southwest side of State Highway No. 101 about six miles northwest of Greer, and being known and designated as Lot No. 16 of the Hazel Edwards Property as shown on plat prepared by J. Q. Bruce, Registered Surveyor, dated February 16, 1960, and which plat has been recorded in the R.M.C. office for said County in Plat Book 00, page 435.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
