WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----

Forty Nine Thousand and No/100----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northwestern side of Wellington Avenue, and being known and designated as "Property of J. R. McQueen and Robert L. Smith" as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book 4-C, Page 191, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northern corner of property now or formerly of Robert L. Smith and running thence along the northwestern side of Wellington Avenue S. 37-01 E. 157.5 feet to an iron pin; thence S. 52-43 W. 183.8 feet; more or less, to an iron pin; thence running N. 37-22 W. 172.1 feet to an iron pin; thence running N. 62-02 E. 89 feet to an iron pin; thence running N. 52-44 E. 97 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
