"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of , Greenville, State of South Carolina, containing one (I acre and, according to plat by T. H. Walker, Jr., L. S., dated August 29, 1970, having the following meter and bounds, to-wit:

Beginning at an iron pin at the joint corner of property hereinsfter conveyed, property of the Grantor, and property now or formerly of Mack D.
