DESCRIPTION OF PROPERTY

Situated in the City of Toledo, County of Lucas and State of Ohio, and known as being the westerly two hundred (200) feet of the easterly three hundred sixty (360) feet of the southerly three hundred eighty-five (385) feet of the following described premises:
