OLLIE FARNSWORTH MORTGAGE MODIFICATION AGREEMENT
STATE OF SOUTH CAROLINA R.M.C.
COUNTY OF GREENVILLE TRAVELERS REST FEDERAL SAVINGS & LOAN ASSOCIATION

WHEREAS, on June 12, 1968, Millard P. Garland did execute a mortgage unto Travelers Rest Federal Savings and Loan Association covering 0.27 Ac U. S. Hwy 276, Marietta, S. C. in the sum of \$3,500.00 recorded in Mortgage Book 1095, page 243 for a term of 12 years at an interest rate of 7 calling for payments of 36.00 commencing Jul 15, 1968.

WHEREAS, the mortgage requires the written permission of the mortgagee for assumption purposes and whereas Paul Roberts have agreed to assume said note and mortgage according to the modified terms hereof.

In and for the mutual considerations to the parties involved, Millard P. Garland & Paul Roberts

do hereby agree that the interest rate shall be increased to 8 per annum to be computed and paid monthly and that the payment hereafter shall be \$ 39.06 per month over the remaining period of the loan which is approximately 9 years. It is understood and agreed that the remaining terms and conditions of said note and mortgage shall remain the same.

ESCALATOR CLAUSE

THE BORROWERS agree that the aforesaid rate of interest on this obligation may, from time to time, at the discretion of the Association be increased to the maximum rate per annum permitted to be charged from time to time by applicable South Carolina Law. Any increase in the interest rate herein set forth shall take effect 30 days after written notice of such increase has been mailed to the obligors at their last known address. During said 30 day period, the obligors shall have the privilege of paying the obligation in full without penalty. In the event the interest rate of this obligation is adjusted as provided herein, the installment payments provided hereinabove shall be increased so that this obligation will be paid in full in substantially the same time as would have occurred prior to such change in interest rate; however, should the term of the obligation be extended by reason of this adjustment, the makers, endorsers and their heirs, personal representatives, successors or assigns, shall remain obligated for the debt.
