MORTGAGE

WHEREAS:

Dewey Lee Perkins and Dawn R. Perkins
Greenville, S. C., hereinafter called the Mortgagor, is indebted to

C. DOUGLAS WILSON & CO.

a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fourteen Thousand Seven Hundred Fifty and no/100 Dollars (\$ 14,750.00); with interest from date at the rate of seven per centum (7 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S. C., or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagee, in monthly installments of Ninety-Eight and 24/100 Dollars (\$ 98.24), commencing on the first day of May, 1971, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 2001.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the southeasterly side of Georgia Road in the County of Greenville, State of South Carolina and having according to a recent survey entitled "Property of Dewey Lee Perkins and Dawn R. Perkins" prepared by Campbell & Clarkson Surveyors, Inc., dated March 5, 1971, and recorded in the RMC Office for Greenville County, S. C. in Plat Book 4-I, page 69, the following metes and bounds, to-wit:

BEGINNING at a point in the center of Georgia Road, said point being the joint front corner of property of grantor and property now or formerly owned by Bennett and running thence S 19-41 E 730.8 feet to an iron pin; thence S 86-40 W 227 feet to an iron pin in the center of branch; thence with center of branch as line the traverse line being N 28-47 W 714.4 feet to an iron pin on the southeasterly side of Georgia Road; thence with the southeasterly side of Georgia Road N 77-00 E 333 feet to an iron pin, the point of beginning.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
