Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Critzens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Spartanburg, near the southern City Limits of the City of Green, east of Poplar Drive Estension, being shown and designated as Lot No. 8 on a plat of property prepared for J. Allen and Nannie Smith by H. S. Brockman, Surveyor, dated June 27, 1966, recorded in Plat Book 56 at Page 644, R.M.C. Office for said County, and having such metes and bounds as are thereby shown. According to said plat, said lot fronts 100 feet on the North side of a new cut County Road ( Pine Ridge Drive).

The above described lot being a portion of the same conveyed to Woodlen A. Bright and Cecil B. Bright by deed recorded in Deed Book 2008 at Page 548, R. M. C. Office for Spartanburg County.

This is the same property conveyed to me By Golden A. Bright and Cecil B. Bright by Deed dated May 28th, 1970 recorded in Deed Book 36 Y, Page 160 in the R. M. C. Office for Spartanburg County.

ALSO: All that certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the City of Greer, lying on the north side of Hubert Street, being the greater portion of Lot No. 2 in a subdivision of property for Bennett and James, and being all of Lot No. 2, less portions heretofore conveyed off, the lot herein conveyed having the following courses and distances, to wit:

Beginning on an iron pin (new corner), the northeastern corner of the lot conveyed herein, and runs thence N. 70-30 W. 56 feet to an iron pin, corner of lot conveyed to Willis; thence S. 20-41 W. 27 feet to an iron pin; thence N. 70-20 W. 3.4 feet to an iron pin on old line between Lots Nos 1 and 2; thence S. 19-30 W. 99.2 feet to an iron pin on the north side of Hubert Street; thence with margin of said street, S. 70-30 E. 60 feet to an iron pin, corner of Lot No. 3; thence N. 19-30 E. 126 feet
