All those certain pieces, parcels or lots of land lying and bieng on the Easterly side of State Highway No. 291, near the City of Greenville South Carolina, being shown as Lot Nos. 4 and 5 on a plat of the subdivision of Lot 9 of the J.H. Sitton property (Plat Book II, Page 127), made by Woodward Engineering Company, dated June 15, 1957, and recorded in the RMC Office for Greenville County, S.C. in Plat Book NN, page 105, and having abcording to said plat the following metes, and bounds to wit:
