(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **NINETEEN THOUSAND SEVEN HUNDRED FIFTY AND NO/100THS**

DOLLARS (\$ 19,750.00.....), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Chick Springs Township**, known as **Lot No. 23 on plat of Grand View Hills** recorded in the R. M. C. Office for Greenville County in Plat Book **WWW**, at page **52**, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Sunset Street at the corner of Lot No. 22, and running thence along said Street, **N 40-12 W 125 feet** to an iron pin; thence along the curved intersection of Sunset Street and Knoll Circle, the chord of which is **N 4-50 E 35.7 feet** to an iron pin; thence along the southeastern side of Knoll Circle, **N 49-51 E 123 feet** to an iron pin at the corner of Lot No. 24; thence **S 40-07 E 150 feet** to an iron pin; thence **S 49-51 W 149.9 feet** to the point of beginning and being the same conveyed to us by deed of **Joseph H. McCombs** to be recorded of even date herewith.
