NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the north side of Starsdale Circle, being shown as Lot 25 on a plat of Starsdale Manor dated March, 1956, prepared by Dalton & Neves recorded in Plat Book NN at page 9 in the RMC office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Starsdale Circle at the joint front corner of Lots 25 and 26 and running thence with Lot 26, N 21-25 W 145 feet to an iron pin at the joint rear corner of Lots 25 and 26; thence with the rear line of Lots 19 and 20, S 68-35 W 100 feet to an iron pin at the joint rear corner of Lots 24 and 25; thence with Lot 24, S 21-25 E 145 feet to an iron pin on the northern side of Starsdale Circle; thence with said circle, N 68-35 E 100 feet to the point of beginning.
