ALL that piece, parcel or lot of land with buildings and improvements thereon, situate, lying and being on the Eastern side of Knoll Circle in Greenville County, South Carolina, being shown and designated as Lot No. 24 on a Plat of a Revision of Grandview Hills made by R. B. Bruce, Surveyor, dated March 31, 1969, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WWW, page 52, reference to which is hereby craved for the metes and bounds thereof.
