WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Eighteen Thousand, Eight Hundred and 00/100 -----

DOLLARS (\$ 18,800.00), with interest thereon from date at the rate of SEVEN & ONE-HALF per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being shown and designated as Lot 36 on a Plat of Eastview Heights, which Plat is recorded in the R.M.C. Office for Greenville County, in Plat Book WW, Pages 126 and 127, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING on the Eastern edge of Eastview Drive at the joint front corner of Lots 35 and 36, and running thence with the joint line of said Lots, N. 79-02 E., 245 ft. to an iron pin at the joint rear corner of Lots 35 and 36; thence, S. 18-38 E., 50 ft. to an iron pin at the joint rear corner of Lots 36 and 37; thence with the joint line of Lots 36 and 37, S. 13-00 W., 195.8 ft. to an iron pin on the Northern edge of Eastview Drive; thence with the edge of said Drive, N. 77-00 W., 161.1 ft. to an iron pin; thence continuing with the edge of Eastview Drive, S. 43-59 E., 45.3 ft. to an iron pin; thence still with said Drive N. 10-58 W., 125 ft. to an iron pin at the point of beginning.
