TO ALL WHOM THESE PRESENTS MAY CONCERN:

SAMMIE G. CRAIGO and
BARBARA J. CRAIGO (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of SIX THOUSAND SIX HUNDRED AND NO/100THS - - - - - DOLLARS (\$ 6,600.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,
July 1, 1986

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Western side of Sulphur Springs Drive near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 9 of the property of R. G. Jones, according to a plat prepared by John C. Smith, dated January 9, 1960, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book TT at page 137, said lot having such metes and bounds as shown thereon.

BEGINNING at an iron pin on the Northern side of Sulphur Springs Drive at the joint front corner of Lots Nos. 8 and 9, and running thence with the line of Lot No. 8 N. 84-20 W. 157 feet to an iron pin; thence N. 2-29 W. 119.3 feet to an iron pin; thence with the line of Lot No. 10 S. 78-26 E. 175 feet to an iron pin on the Western side of Sulphur Springs Drive; thence with the Western side of Sulphur Springs Drive S. 5-40 W. 100 feet to the point of beginning.

This is the identical property conveyed to the mortgagors herein by deed of Rector G. Jones and Iza C. Jones, dated February 10, 1960, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 644 at page 338.
