(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as a portion of lot 2 on plat of Avice Dale recorded in Plat Book B at page 53 in the R.M.C. Office for Greenville County and having the following metes and bounds:

BEGINNING at an iron pin on the northwestern side of Avice Dale Drive at the joint front corner of lots 1 and 2 and running thence with the line of lot 1, N. 62-30 W. 200 feet to an iron pin; thence with a new line through lot 2, S. 28-30 W. 130 feet to an iron pin; thence another new line through lot 2, 225 feet in a southeasterly direction to an iron pin on the northwestern side of Avice Dale Drive; thence with the northwestern side of Avice Dale Drive; thence with the northwestern side of Avice Dale Drive N. 15-08 E. 49.3 feet and N. 20-30 E. 80.7 feet to the beginning corner.

Being the same property conveyed to me by deed recorded in Deed Book 917 at page 601 in the R.M.C. Office for Greenville County.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's account and collect it as part of the debt secured by the mortgage.

The mortgagor agrees that after the expiration of ten years from the date here of, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
