

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 72 on the plat of Magnolia Acres as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG page 133 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northwesterly side of Fleetwood Drive at a point 161.6 feet southwest of the westerly corner of the intersection of Fleetwood Drive & Cool Brook Drive, said pin being the joint corner of Lots 72 & 52 and running thence along the joint line of said lots N. 21-10 W. 112 feet to an iron pin, joint corner of Lots 52, 53 & 72; thence with the line of Lot 53, N. 74-33 W. 100.6 feet to an iron pin corner of Lots 53, 54, 55 & 72; thence with the line of Lot 55, S. 68-50 W. 9 feet to an iron pin, joint rear corner of Lots 71 & 72; thence with the joint line of said lots S. 21-10 E. 172 feet to an iron pin on the northwesterly side of Fleetwood Drive; thence along the northwesterly side of said Drive N. 68-50 E. 90 feet to the point of beginning.
