All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina County of Greenfville, on the southeastern side of Toledo. Street (formerly Marlin Street), being known and designated as Lot No. 50 and the northeastern 10 feet of Lot No. 49, as shown on plat of Estate of O. M. Perry, prepared by R. E. Dalton, Engineer, dated May 1923, and having, according to a more recent survey prepared by Dalton and Neves, Engineers, dated October 19, 1950, the following metes and bounds, to-wit:
