NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

a one-third undivided interest in

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying end

Greenville, and being shown and designated as Lot No. 6 on plat of property of R. L. Hallman, Jr. and M. L. Propp, recorded in Plat Book KK, Page 94, RMC Office for Greenville County, and being also designated according to a survey and plat of J. C. Hill dated January 16, 1959, as follows:

BEGINNING at an iron pin on the southern side of Piedmont Avenue Extension near the Town of Piedmont, corner of lot No. 5; thence with said Avenue S. 76-43 F. 69.9 feet to a stake; thence with said Avenue S. 59-55 F 43.1 feet to iron pin in line of Lot No. 7; thence with line of Lot No. 7 S 7-41 W 178 2 feet to an iron pin; thence No. 89-13 W 41 feet to a stake; thence NO. 71-0 W 88.7 feet to an iron pin in line of Lot No. 5; thence with line of said lot N. 13-17 F. 189.5 feet to the beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all lions and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
