"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 12 of Block N of a subdivision known as Highland, also known as the Property of N.H. Harris according to plat recorded in the RMC Office for Greenville County in Plat Book E at page 205, and fronting on the eastern side of Florida Avenue.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter aftached, connected, or fitted thereto in any manner; it being the intention of the patties hereto that all such fixtures and equipment, other than the usual hopsehold furniture, be considered a part of the real estate.
