"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Mostern side of Foot Hills Road near the City of Greenville, County of Greenville, State of South-Carolina, being known and designated as Lots Nos. 68 and 69 as shown on a plat of Green Valley Bstates, prepared by Piechaont Inginegring Service, dated December 20, 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "QQ" at pages 2, and 3, and having, according to said plat, the following motes and bounds:

S. 20-51 W. 43.6 feet; thence continuing with Crapemyrife Drive S. 69-05 W. 210.0 Feet to a point at the joint corner of hots Nos. 69 and 70; thence with the line of Lot No. 70 N. 36-08 W. 193.5 feet to a point in the joint rear corner of Lots Nos. 69 and 70; thence N. 60-08 B. 55.0 feet to a point in the joint real corner of Lots Nos. 67 and 68; thence N. 20-15 W. 193.1 feet to a point at the joint corner of Lots 80s. 67 and 68; thence N. 50-24 B. 100.0 feet; thence rounding the curve of the intersection of Red Bud Lane 100.0 feet; thence rounding the curve of the intersection of Red Bud Lane and Foot Hills Road S. 68-29 B. 34.3 feet; thence continuing with Edotalliks Road S. 13-22 B. 180.0 feet to the beginning.
