Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain
conditions), said note to be repaid with interest as the rate or rates therein specified in installments of _ONE_HUNDRED
AND 90/100
WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE; known and designated as Lot No. 110 on plat of Pleasant Valley Subdivision recorded in the RMC Office for Greenville County in Plat Book P at Page 92, said lot having a frontage of 60 feet on the south side of Pleasant Ridge Avenue a parallel depth of 160 feet & a rear width of 60 feet.

BEGINNING at an iron pin on the S. side of Pleasant Ridge Avenue joint front corner of Lots 110 and 111, said pin being 210 ft. S.W. of iron pin in the southwest corner of intersection of Panama Avenue with Pleasant Ridge Avenue; thence S.O.O8 E. 160 ft. to an iron pin at joint rear corner of Lots 110 and 111; S. 89-52 W. 60 ft. to an iron pin at joint rear corner of Lots 110 and 109; thence N.O.O8 W. 160 ft. to an iron pin on S. side of Pleasant Ridge Avenue at joint front corner of Lots 110 and 109; thence along said Avenue N. 89-52 E. 60 ft. to an iron pin at joint front corner of Lots 110 and 111 to point of beginning.
