NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Waddell Road, near the City of Greenville, being shown as Lot 38 on a plat of Wade Hampton Gardens, recorded in Plat Book MM at page 199, and described as follows:

BEGINNING at an iron pin on the Western side of Waddell Road, 210 feet South from Lee Road, at the corner of Lot 37, and running thence with the curve of the Western side of said Road, the chord of which is S. 19-24 W. 100 feet to an iron pin at the corner of Lot 39; thence with the line of said lot, N. 73-29 W. 159 feet to an iron pin in line of Lot 33; thence with the lines of Lot 33 and Lot 34, N. 18-57 E. 110.1 feet to an iron pin at the corner of Lot 37; thence with the line of said lot, S. 73-29 E. 159.8 feet to the Beginning corner.
