NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville. All that certain piece, parcel or lot of land situate, lying and being on the northeastern side of Skyland Drive (formerly Bates Avenue) in the City of Greenville, in the County of Greenville, State of South Carolina and known as designated as Lot No. 33 of a subdivision known as Skyland Park, plat of which is recorded in the R.M.C.
