"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, on the Northern side of Public Road, containing 8 acres, more or less, and having, according to a plat of "Property of G. C. Jones" prepared by W. J. Riddle, Surveyor, April 25, 1934, and recorded inthe RMC Office for Greenville County, South Carolina, in Plat Book K at page 20, the following metes and bounds, to wit:

BEGINNING at an iron pin in the center of Public Road and running thence N. 20-30 W., 336 feet to an iron pin; thence N. 9-10 E., 329 feet to an iron pin; thence N. 18 W., 532 feet to an iron pin; thence S. 88-20 E., 464 feet to a stone; thence S. 1 W., 586 feet to a stone; thence S. 82-45 W., 47.5 feet to a stake; thence S. 4-45 E., 482 feet to a point in the center of said road; thence in a Southwesterly direction along the center of said road to the point of beginning.
